

How can country reports be obtained?



One way to do so is to log in to the [EBSCO](#) resource and then select [Country Reports](#) on the menu.

By other means, in [ABI/INFORM Global](#), resource, by clicking on [Economist Intelligence Unit \(EIU\) ViewsWire](#) and select location, subject, and date. Find country reports on the business environment, corporate strategy, economic forecasts from 2 to 5 years, product analysis, country risk classification, macroeconomics, and economic and political structure.



What sort of country reports, other than sectoral, can be developed?

An extensive variety of reports can be elaborated from several topics, e.g.: trade balance, underground economy, budgets, capital movements, commodity economics, fiscal policy, etcetera using [**ABI/INFORM Global**](#) resource.

Please, note that all these options can be reached directly from [**E-resources and databases**](#).

Are there any available reports on statistical profiles organized by country demography, industrial production, imports, exports, consumer prices, the balance of payments, and employment?

While using [**OECD \(Organisation for Economic Cooperation and Development\)**](#) it is feasible to gain access to [**Database Access**](#), demographics and population statistics, development, economic projections, environment, finance, globalization, health, industry and services, technology information and communication, international trade and balance of payments, work, national accounts, monthly economic indicators, etc.

[**OECD Stat**](#) also includes data and metadata for OECD countries and economies of selected non-members, as well as it allows data access to general statistics in [**Statistical Tools**](#), development, economic projections, demographics and population statistics, flow by suppliers, profitability statistics, monthly financial statistics, pensions, financing to SMEs.

[**Statista**](#) adds stat data on more than 600 international industries gathered from more than 18,000 sources, including those from market researchers, organizations, journals, and government databases.

[**Factiva**](#) focuses on sectoral information, using the option Companies/Markets, once located Industry. Inquiries can also be performed by Quotes and Market Data Charts.

[**Just-Series Market Research Reports**](#) performs searches for market reports on industries by [**Subject**](#), by [**Industry**](#), and by [**Title**](#).

Complete the search with [**Statista**](#). Look for stat data on more than 600 international industries gathered from more than 18,000 sources, including market research, organizations, journals, and government databases.


How can reports from differing industries related to a particular country be found?
